1. “*Vendor*” agrees to accept space assigned.
2. “*Vendor*” agrees to the following conditions:
 - a. For Parade Route space set up shall be completed between 9 am and 9:30 am and tear down at 11:30 am July 5, 2025.
 - b. For Campus spaces set up shall be complete by 12:30 pm and tear down at 4:30 pm on July 5, 2025.
 - c. Will provide own electricity, if needed.
 - d. Only items specified in the application may be sold.
 - e. “*Alumni*” may close any “*vendor*” space at any time for failure to observe and comply with this agreement
 - f. “*Vendor*” will keep their assigned space clean and remove all trash from the premises. .
